#### **Proclamation – National Donate Life Awareness Month**

Mr. Ralston shared his personal story of receiving an organ to save his life. He encouraged everyone to register as organ donors through the DMV and Donate Life California Donor Registry. Captain Steve Tevis shared his personal story of receiving an organ to save his life and expressed his sincere gratitude to his organ donor who was in attendance.

# Fred L. Burns Award - Anne Magallanez

#### Hometown Hero Award and Survivor Recognitions

They honored the Hometown Heroes, Firefighters/Parmedics, Police Officers, Dispatchers, and Hospital Staff who assisted the CPR survivor as well as paid tribute to the CPR Survivors. Awards were presented and the Chino Valley Fire District Challenge Coins were given to the CPR survivors and members of the life saving team. Deputy Chief Ault explained that the Challenge Coin was meant to represent the life saved and the relationship between the survivor and the team members who assisted in their survival. An honorary Challenge Coin was given to the CPR survivor and ceremoniously placed on the Survivor Board displayed at Chino Valley Fire District Headquarters.

The CSDA Board of Directors is the governing body responsible for all policy decisions pertaining to CSDA's member services and legislative advocacy, education and resources.

Clerk of the Board Robles reported that Costa Mesa Sanitary District representative Arlene Schafer is the current incumbent for the Southern Network, Seat C. Ms. Schafter has stated that she would like to run for reelection. It was note that all qualified nominations must be received by April 6, 2023, according to CSDA.

RECOMMENDATION: It is recommended that the Board of Directors review, discuss, and consider adoption of Resolution No. 2023-02, nominating a Fire District Board Member as candidate for the Special District Risk Management Authority (SDRMA) Board of Directors 2023 Election or decline to participate.

Clerk of the Board Robles stated that every two years the Fire District may nominate one individual for election to the SDRMA Board of Directors, such as a Fire District Board Member or managerial employee. The SDRMA Board of Directors is the governing body responsible for establishing policy, providing oversight, and setting direction and vision to ensure SDRMA meets its mission, obligations and commitment to its members.

Clerk of the Board Robles reported the upcoming election is for three (3) Director seats, each for a four-year term beginning on January 1, 2024 and ending December 31, 2027. candiates must be nominated by resolution and statement of qualification must be received by May 1, 2023, according to SDRMA. Additionally, it was noted that the incumbents intend to run for reelection.

The Board decided unanimously not to submit a candidate nomination for the SDRMA Board of Directors 2023 Election.
