PURPOSE:

Purpose of this report is for the Board of Directors to review, approve and adopt Resolution No. 2023-09 allowing the Fire District to recover costs for weed abatement services for Spring 2022, Fall 2022 and round-one inspections for Spring 2023.

DISCUSSION:

The Fire District has concluded abatement of weeds and combustible vegetation in the community. Attached are the cost reports for all parcels that were identified by Fire District staff as requiring abatement and which have not paid incurred fees. These property owners are given the opportunity to pay the Fire District directly for these costs, but have not done so as of the date of this report. The fees are for Fire District administrative costs and actual costs for abatement by our private contractor.

Under the authority of the California Health and Safety Code (Division 12, Part 5, Chapter 4, Article 1 [14905-14906]), Resolution 2023-09 allows the posting of a cost report and an assessment hearing regarding the report and the ability to collect costs owed to the Fire District through assessment of said properties. The cost reports are attached and were posted for at least three (3) days required prior to the meeting of the Board of Directors at the Fire District Administrative Office, as well as the Fire District's website.

Once adopted, Resolution 2023-09 will be forwarded to the County Auditor/Controller Recorder so the Fire District's costs may be placed on this year's tax roll.

RESOLUTION OF THE BOARD OF DIRECTORS OF THE CHINO VALLEY INDEPENDENT FIRE DISTRICT FOR CONFIRMATION AND RECOVERY OF COSTS FOR WEED ABATEMENT SERVICES

WHEREAS, having identified weeds located upon the streets, sidewalks and private property within the Chino Valley Independent Fire District; and

WHEREAS, said weeds constitute a public nuisance, and/or potential or existing fire hazard; and

WHEREAS, notices were sent to all property owners needing weed abatement; and

WHEREAS, a private contractor was used to abate weeds and/or vegetation constituting a fire hazard from such properties specifically referenced in the attached cost report; and

WHEREAS, in addition as allowed by law and due to personnel time and expertise needed to direct the abatement process, separate fees are charged for administrative procedures and for services, for the remaining parcels referenced in the attached cost report; and

NOW, THEREFORE, the Board of Directors of the Chino Valley Independent Fire District does hereby resolve as follows:

SECTION I. As provided by statute, the Fire District has kept an itemized account of the costs of abatement for each parcel, including, but not limited to direct and indirect costs (such as actual removal, investigation, boundary determination, measurement, clerical, administrative and overhead).

SECTION II. The cost reports have been posted for at least three (3) days, at the Chino Valley Independent Fire District Administrative Office prior to this meeting at which they are submitted to the Board for approval. Those to be assessed were notified by a Notice to Destroy Weeds, delivered or postmarked between the dates of May 9, 2022 through August 1, 2022 for Spring cycle 2022; September 16, 2022 through November 1, 2022 for Fall cycle 2022; and May 10, 2023 through May 27, 2023 for Spring cycle, Round 1 inspections. In addition, this assessment hearing was published in a newspaper of general circulation in the District, as required.

SECTION III. The cost reports have been considered at a public meeting. The objections of any property owners liable for the procedural abatement cost has been heard and considered and the Board of Directors made such modifications as necessary.

SECTION IV. The cost reports, as modified, are hereby confirmed and shall be adopted by resolution and recorded in the County Auditor/Controller-Recorder's Office. The costs thereafter shall constitute special assessments against that property and become

a lien against that property at the time of recordation of the resolution of confirmation (Attachment A).

SECTION V. Special assessments, when recorded, shall become a lien against that property and will be collected at the same time and in the same manner as county property taxes are collected and subject to the same penalties and procedures in the event of delinquency including foreclosure except that if any real property to which such lien would attach has been transferred or conveyed to a bona fide purchaser for value, or if a lien of a bona fide encumbrance for value has been created and attached thereon, prior to the date on which the first installment of such taxes would become delinquent, then the lien which would otherwise be imposed by this section shall not attach to such real property and the costs of abatement and the costs of enforcing abatement, as confirmed, relating to such property shall be transferred to the unsecured roll for collection.

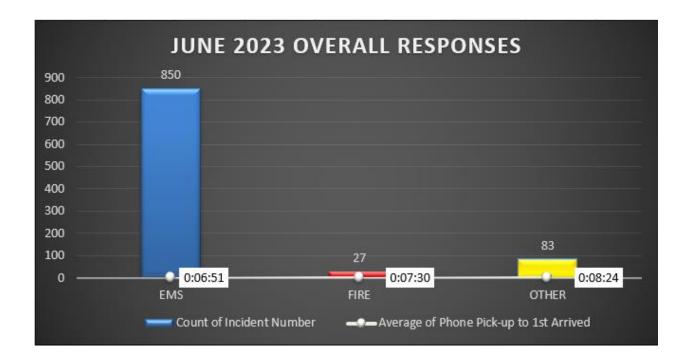

SUBJECT: MONTHLY FINANCIAL REPORT - JULY 2023

PURPOSE:

The purpose is to present the Chino Valley Fire District's financial activity for the month ended July 31, 2023, and for the fiscal year-to-date in comparison to the Amended budget.

DISCUSSION:

This report provides revenue and expenditure information for the month of July 2023, and for the fiscal year in comparison to the 2023-24 amended budget and the prior year-to-date actual amounts.

Cyclical Nature of District Revenues and Year-End Adjustments

As District revenues are largely cyclical, the majority of District property tax revenues are received during the November/December and April/May timeframes. Readers of the District's monthly financial reports should be cautioned when drawing conclusions regarding total revenues minus total expenses in any given month. Generally, over time, a more meaningful comparison may be drawn between the current and prior year-to-date totals, as well as the year-to-date variances between budgeted and actual financial performance. Additionally, there are a number of required adjustments to the District's financial statements after each fiscal year-end which can have a significant impact on the final numbers for the fiscal year. Over the course of the fiscal year, the attached two-year revenue and expenditure comparison graphs are intended to provide a summary comparison of the District's total revenues and expenditures between the current and prior fiscal year-to-date.

RECOMMENDATION:

It is recommended that the Board of Directors of the Chino Valley Fire District receive and file this financial report.

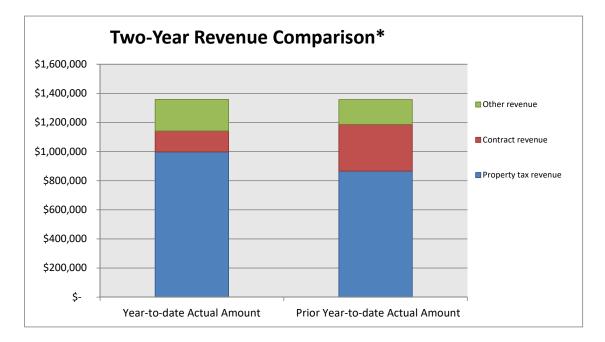

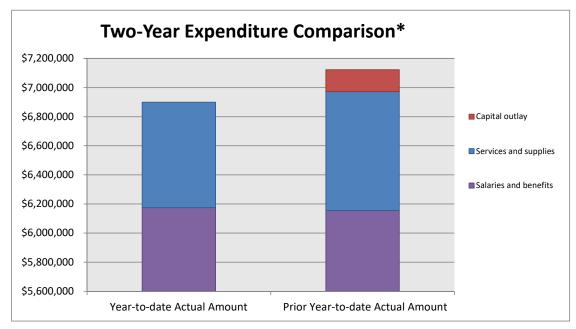

SUBJECT: MONTHLY TREASURER'S REPORT - JUNE 2023

PURPOSE:

The purpose of this report is to inform the Board of Directors of current investment activities of the Chino Valley Fire District.

DISCUSSION:

Attached is a summary of the cash in bank and District investments. The information is displayed graphically as follows:

Chart 1: Presents a Two Year Overview of Cash Deposits and Unrestricted Investment Funds.

Chart 1A: Presents a One Year Overview of Restricted Investment Funds.

Chart 2: Presents an Overview of Total Cash and Unrestricted Investments beginning January 1996 to date.

Chart 3: Presents an Overview of the Rate of Return from the LAIF account beginning January 1996 to date.

As the District generally observes a "buy and hold" strategy, the District typically holds investments until maturity, unless called by the issuing agency, if applicable. Accordingly, fluctuating market values of the District's fixed instrument investments, while noted in this report, are only realized if these investments are liquidated prior to maturity. Government accounting standards require that the District account for market values below cost, if applicable.

In FY17, the District deposited \$5 million into a Section 115 Retirement Trust and another \$2.45 million after inception. Funds accumulated in the Trust are legally restricted for use in paying down pension obligations. Accordingly, 115 Trust funds are reported in the Treasurer's Report as restricted investments. Chart 1A also includes funds received in February 2022 from the City of Chino Hills under an agreement for construction of Fire Station 68 in Chino Hills. By agreement, these funds are

restricted for construction of the new fire station.

The Sweep earned a posted rate of return of 0.10% as of June 30. The monthly average rate of return on the LAIF account was 3.167% for June.

RECOMMENDATION:

It is recommended that the Board of Directors receive and file this Treasurer's Report for the period.

Chart 1: Cash & Unrestricted Investment Balances Two Year Perspective

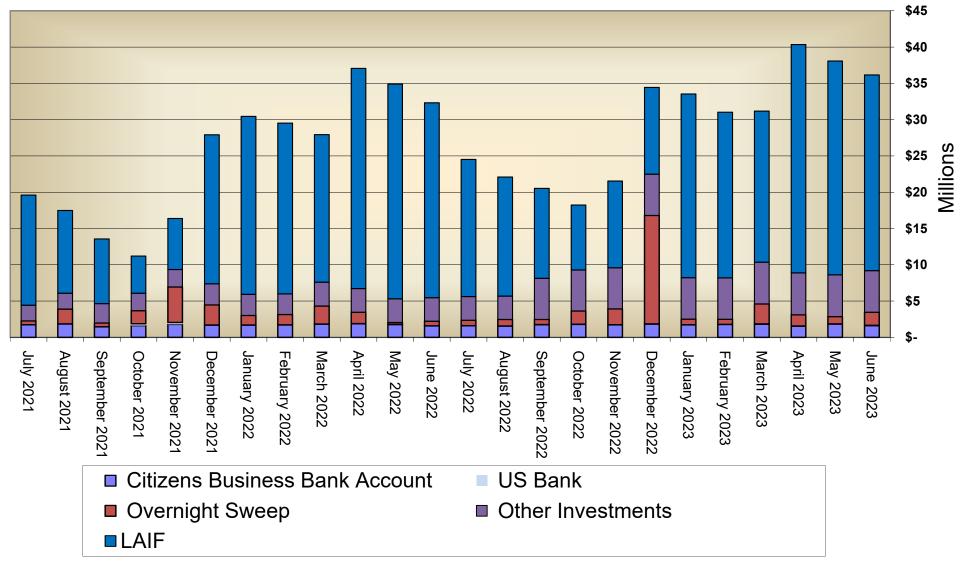
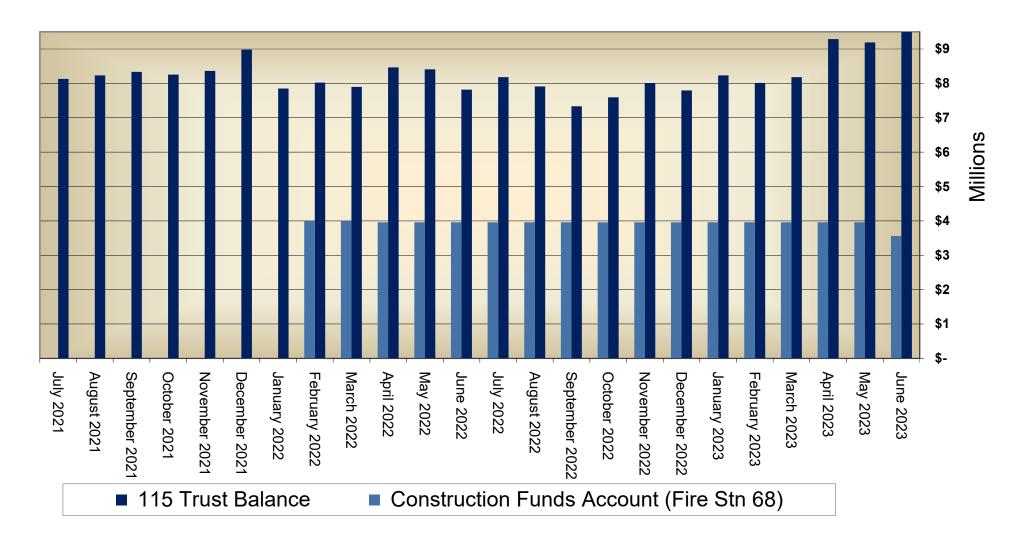




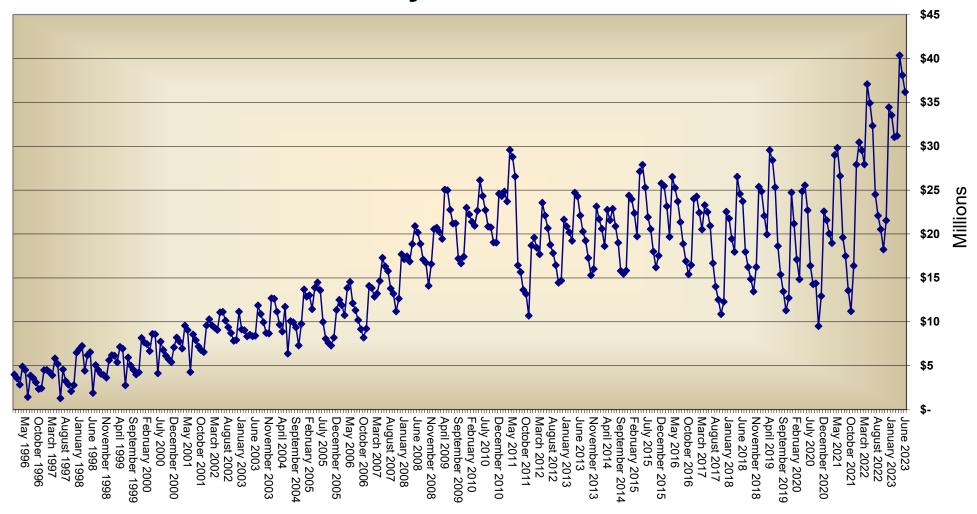
Chart 1A: Restricted Investment Balances Two Year Perspective

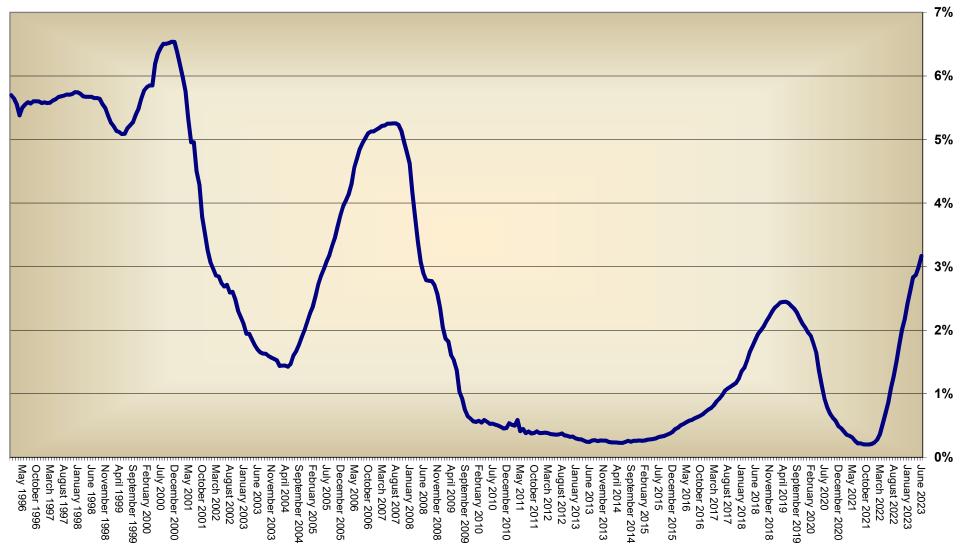
Chart 2: Total Cash & Unrestricted Investments January 1996 to date*

Purpose is to present, review and discuss an update to the current CVFD Standards of Cover Assessment and develop a Strategic Plan in accordance with GFOA requirements and standards.

DISCUSSION:

Planning for the future is a key function of Highly Reliable Organizations. The District has planned well to meet the needs of our growing communities, as evidenced by the District's exceptional quality of service, high employee engagement, remarkable facilities, and modern apparatus. A key principle of such planning is adherence to a cycle of assessment, development, implementation, and reassessment. Effective planning tools include workshops, stakeholder engagement, and a Standards of Cover Assessment (SOC). A comprehensive strategic plan is the product of this process.

In collaboration with the Board, staff is beginning the process of updating the CVFD Strategic Plan. This process will consist of three main phases: a workshop with the CVFD Board of Directors, an update to the current SOC, and the development of the CVFD Strategic Plan. This comprehensive strategic plan will provide a roadmap for future growth and satisfy a future requirement of the GFOA (Government Finance Officers' Association) Distinguished Budget Award, of which the District is a current recipient.

The upcoming workshop with the CVFD Board of Directors will allow an opportunity for dialogue between the Board and staff and provide potential ideas for internal and external stakeholder engagement.

The current Standard of Cover assessment is due for an update. The District engaged with Citygate Associates in 2017 to conduct a SOC assessment and an update to the District's Master Plan. This

comprehensive analysis provided insights that identified the potential future needs of the District. A prominent result of this effort validated the community's expectations and need for the development of Fire Station 68. Staff will work with Citygate to update the current SOC as a foundation for further strategic plan development. This update will focus on gap analysis and a future needs assessment.

After conducting the Board Workshop and updating the SOC, staff will work with Citygate to formalize the CVFD Strategic Plan. This plan will provide a roadmap for implementing goals developed according to this process, consistent with the District's Mission, Vision, and Values.

RECOMMENDATION:

It is recommended that the Board review and discuss an update to the current CVFD Standards of Cover Assessment and the development of a Strategic Plan, in accordance with GFOA requirements and standards.
