Finance Director Shaker stated in FY17 the District adopted the Chino Valley Fire District 115 Retirement Trust, which specified that $1/3^{rd}$ of annual excess revenues, or budget surplus, shall be allocated toward the accelerated reduction of pension liabilities.

Finance Director Shaker reported the District's FY22 ACFR reported annual excess revenues in the General Fund of \$4,811,320. In accordance with the surplus policy, 1/3rd of the calculation would generate \$1,399,474 in additional pension funding.

Finance Committee discussed the proposed allocation of the surplus funds and payment options for the pension liabilities.

There was no request from the public to speak on this item.

The Finance Committee agreed to place this item on New Business for consideration of approval by the Board of Directors at the next regular meeting.
